Our customers include national and regional house builders, developers, landowners, and contractors. Our diverse businesses also have interests in several utility-related retail businesses, providing telephony and data, water, wastewater, and heat-energy services, directly to end consumers connected to our networks.

The apprenticeship is based at our head office located in Woolpit, Suffolk. Out of over 2000 employees across the UK, our head office accommodates over 500 staff and offers free car parking and a subsidised staff restaurant on site.

## **Scheme Overview**

### **What is it?**

- The BUUK Regulation Apprenticeship scheme is a perfect opportunity for hard working, talented individuals who are aiming to complete, or completed level 3 education (A-Levels, BTEC Nationals, or equivalent) and are looking towards their first or next step of their career and want to focus on working whilst studying.
- At BUUK, we offer a 3-year Regulation Apprenticeship programme for those who want to focus on working in our corporate centre whilst studying for a degree. We will give you a taster of life in key corporate business support function. You'll experience working with a varied subsidiary companies in our group. You will have the opportunity to develop working understanding of several disciplines from project management, strategic change, compliance, and audit as well as financial analysis, helping you find the future career path which is right for you.
- Whilst developing your skills on the job we offer a BA (Hons) Chartered Manager degree through an external provider. You'll be given time each week to study remotely and time to put your learning into practice 'on the job'.

### **Your First Month**

- Starting the Regulation Apprenticeship scheme with BUUK, you will become part of a Great Place to Work! You will be given a mentor through the 3-year programme as you try out several different roles. They will be your constant support and your guide.
- From day one you will be provided with a company laptop and accessories, and we'll help you find your way around email, making voice and video calls and whatever else you need to help you fly.
- You'll tour the Regulation Department and wider business at our Suffolk based HQ in Woolpit and get to know the people and teams you'll be working with over your apprenticeship.

- You won't be the only one! There are existing apprentices already working with us and we have developed a support network from the get-go to help apprentices transition into working life.
- In your first month you'll be given an introductory accelerated learning of the various disciplines within the programme. Shadowing others in the role, you'll spend some time in each of areas below:
  - Public Affairs
  - Internal Audit
  - Pricing
  - How policy, regulation, and governance changes
  - An overview of regulation in:
    - Heat network provision
    - Electricity networks
    - Gas networks
    - Water and wastewater supply
    - Fibre network communication



### Role Rotation

For the three years, there will be a job rotation around the six areas below. Each role will take roughly 6 months to complete and will provide apprentices with a foundation level of experience, enabling specialism selection after year 3 of the programme. The job rotation is aimed to complement the degree modules and help apprentices apply what they are learning on the degree course with their work.

## Completion of the scheme/Future Opportunities

The apprenticeship programme spans over 3 years.

When the programme has been completed you will no longer be an apprentice but a fully-fledged member of the team, in your chosen area with good progression opportunities.

## Degree Options

As a part of our apprenticeship scheme BUUK offer a 3-year BA (Hons) Chartered Manager Degree Apprenticeship (CMDA) at Anglia Ruskin University.

- Professional accreditation – receive an industry-recognised CMI professional qualification.
- Study while you work, with no tuition fees.
- Work-based approach allows you to deliver impact in the workplace as you learn.



You'll spend time out of work with tutor supported study covering a variety of modules which you will then put into practice at BUUK, working with your mentor and rotational manager. This will cement your understanding in a pragmatic and applicable way.

You will build a portfolio, recording evidence of the application of your knowledge, as well as skills and behaviours you've learnt on the way. It's also important to record feedback from managers, peers, and customers.
